 - Reduced seasonality






NEED TO MODERNIZE

- Investment in Emerging Food regulatory concepts adapted to Innovation requirements
 - **•** E.g. concepts of co-regulation

Leverage opportunities to promote food regulatory convergence internationally But


- Where is the place of novel foods in Codex




