1. Executive Summary

This report presents the activities and deliverables completed by the **Global Food Regulatory Science Society (GFoRSS)** through **FoodRegSci Europe SAS** under the **FoodSafeR Project**, covering the period 2023–2025. GFoRSS–FoodRegSci contributed to the project's dissemination, stakeholder engagement, and promotion of data-driven regulatory science for safer and more resilient food systems globally.

Over the reporting period, GFoRSS–FoodRegSci has:

- Led and co-organized major consortium and dissemination events, including the 2nd and 3rd Annual FoodSafeR Consortium Meetings in Burgos (2024) and Paris (2025), and the FoodSafeR Dissemination Workshop "Science Empowering Food Safety Systems".
- Integrated FoodSafeR themes into flagship international conferences such as FoodMicro 2024, IUFoST 2024, Dubai International Food Safety Conference 2024, and the Oman Food Safety and Quality Conference 2025, reaching over 1,000 regulators, scientists, and stakeholders from more than 40 countries.
- Produced more than 15 high-quality multimedia outputs, including promotional, summary, and digital hosting videos—enhancing the project's visibility across professional networks and social media platforms.
- Established and promoted the Food Regulators Forum (AFoRNet) as a
 collaborative regional platform connecting regulatory authorities from Africa,
 Asia, and the Arab region, fostering dialogue on harmonization and risk-based
 regulatory approaches.
- Supported capacity building by integrating FoodSafeR findings into training materials and sessions, contributing to the forthcoming White Paper on Food Regulatory Transformation.

These actions have enhanced visibility, collaboration, and impact of the FoodSafeR Project globally.



2. Background and Context

The Global Food Regulatory Science Society (GFoRSS), represented by FOODREGSCI Europe SAS, participates in the FoodSafeR Project as part of the broader FoodSafeR initiative.

Under its mandate, GFoRSS—FoodRegSci supports the dissemination and integration of project outputs within the global food regulatory community, ensuring that data-driven decision-making and regulatory modernization are prioritized.

3. Objectives and Terms of Reference

As outlined in the Terms of Reference, GFoRSS-FoodRegSci's role includes:

- Dissemination of FoodSafeR outputs globally, emphasizing data-driven decisionmaking in developing countries.
- Convening of regulatory stakeholders to identify and validate post-pandemic drivers of change in food regulatory systems.
- Integration of project results into the International Symposium to ensure longterm visibility.
- Adaptation of ICT tools and capacity-building programs to disseminate FoodSafeR findings.

AFoRNet is an informal yet structured network designed to strengthen collaboration among food regulators across the region. It enables regular engagement, coordination on emerging issues, joint initiatives to optimize resources, harmonization of food regulatory decisions, and shared efforts in capacity building — all while enhancing existing regional and sub-regional partnerships. 4.2.5 World Food Safety Day Celebration 2023:

A Special Event co-convened by the National Food Safety Agency (NFSA) of Egypt and the Egyptian Organization for Standardization and Quality (EOS), host of the Egyptian Codex. The event highlights the importance given by Egyptian food stakeholders to Food Safety, with special addresses from the leadership of both Organizations and the leadership of the Chamber of Food Industries (CFI).

The event also features an introduction to future efforts of modernization of the Egyptian Food Safety Frameworks.



This event also includes a keynote lecture by Prof. Rudolf Krska, FoodSafer, BOKU university, Austria, reviewing challenges of food safety for the upcoming period. These engagements contributed to global recognition of the FoodSafer initiative and strengthened its stakeholder network.
